1. Information We Collect

We collect the following types of information:

Personal Information:

- Name, email address, phone number, address
- Payment information for purchases or subscriptions
- User account details and preferences

Game Data and Player Information:

- Player performance data (e.g., statistics on movement, reaction times, accuracy)
